

SOUTHEND - THE ROYALS SHOPPING CENTRE









LOCATION

Southend was granted city status in 2022 and is one of Essex's principal commercial centres located 45 miles east of London.

Southend Airport is the UK's fastest growing airport serving 2 milion passengers in 2019.

6.4 million tourists visit Southend each year and the University of Essex and South Essex College are home to 13,179 and 11,000 students, respectively.

The Royals Shopping Centre is the principal shopping centre serving Southend-on-Sea and anchors the southern section of the pedestrianised High Street. It is unique having unobstructed views onto Southend Pier.

The Centre comprises a covered shopping centre which extends to 284,959 sq ft with an adjoining 450 space multi-storey car park.

The Centre is anchored by TK Maxx and Boots, with other occupiers including H&M, Hotter Shoes, Toni & Guy, Pandora and BB's Coffee & Muffins.


